

# 2012 License Application

## Instructions:

1. Complete the application below for your 2012 cat or dog license. A separate application is needed for each animal.
2. ***Proof of rabies must be submitted with each license application.*** All certificates received will be returned with the new license. Any rabies vaccine which expires before November 1st of the licensing year will require an updated vaccine prior to the issuance of a 2012 license. This is mandatory for both dogs and cats. (The State Health Department specifically recommends revaccination every two years.)
3. ***Proof of spaying or neutering is required for all new licenses. (Dogs and Cats)***
4. Enclose a check or money order with the correct amount and a **self addressed stamped envelope. Please send a separate check or money order for dogs and cats.**

6. **Note :** Failure to purchase your license by January 31, 2012 will result in a **\$5.00 late fee per animal** and possible court action taken.
